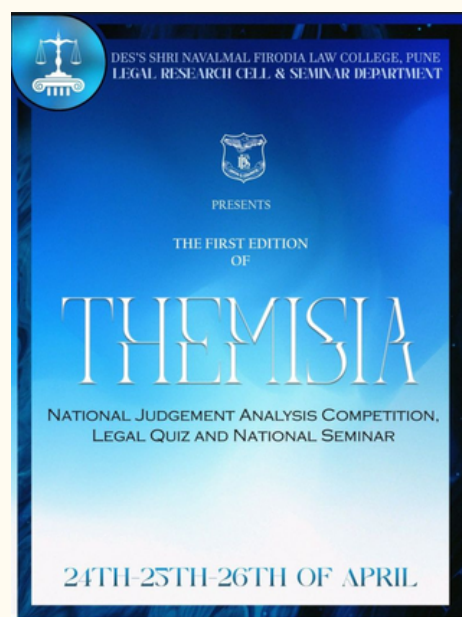
The college also has Law Research Journal "Fiat Justitia", with ISSN No.2320-2696.

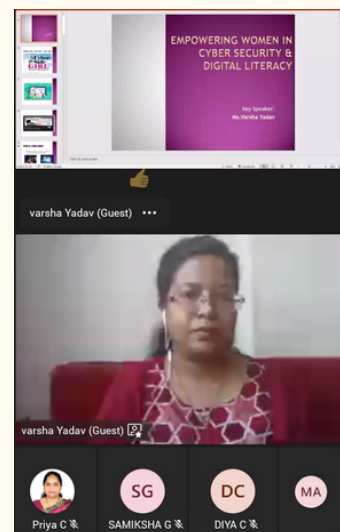

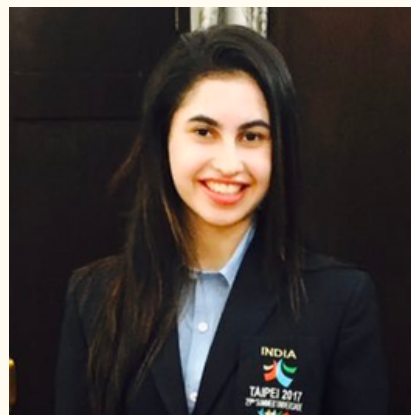
