History & Legacy

Instituted in the memory of Shri. Gopal Ganesh Agarkar — a reformer and the second principal of Fergusson College — the festival has grown from a single debate competition into a Three-format celebration of reasoned public discourse, drawing colleges from across the world each year.

Debate



Debate will be conducted in English, Hindi and Marathi across the preliminary and final rounds. Debate tests two-team argumentation and rebuttal; Elocution, like the first round, tests individual extempore public speaking — both judged on content, delivery, and command of language. Both are treated as a single combined format, with the same rules, schedule and registration fee applying to each.

Format

- ❖ Trilingual: English, Hindi, Marathi
- ❖ Preliminary & Final rounds
- ❖ Strict individual/team time limits
- ❖ No reference material is permitted

Judgment Criteria

- ❖ Content, logic & evidence
- ❖ Delivery & command of language
- ❖ Audience engagement
- ❖ Time management & decorum

Asian Parliamentary Debate



Two benches — Government and Opposition— comprised of three speakers each contest a motion revealed shortly before the round, closing with a Reply Speech from either side.

Speaker Order

1st Proposition → 1st Opposition → 2nd Proposition → 2nd Opposition → 3rd Proposition → 3rd Opposition → Opposition Reply → Government Reply

Adjudication

- ❖ Panel of trained judges
- ❖ Scored on matter, manner, and method
- ❖ Oral adjudication after each round

Draw of lots will be taken for -

- Deciding Ruling/Opposition
- Topic of Debate

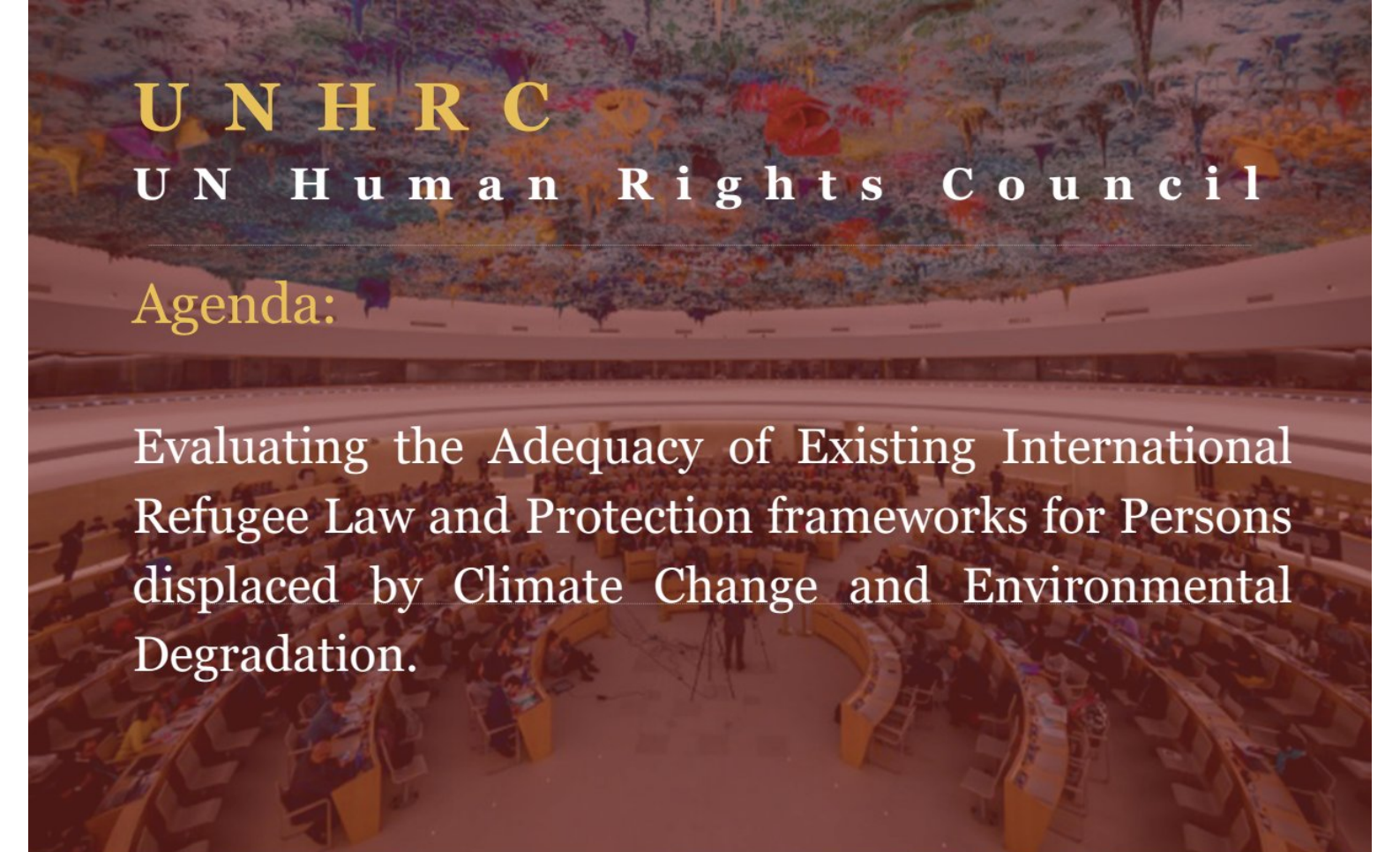

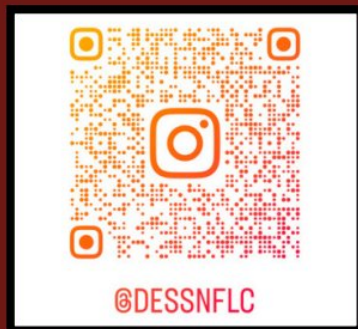
